**NO SALE OF TOY WEAPONS WILL BE ALLOWED AT THE FESTIVAL.**

Tearing down will begin at 10pm on Saturday. If you must tear down early you must receive permission from Katie Slimick, Danny or Agnes Hamilton.

Application deadline: August 15, 2025.

All accepted applications will be required to attend an in-person vendor meeting prior to the Festival.

Note: All vendors must adhere to set-up schedules due to road / festival closures for safety and security. Absolutely no vehicles allowed to enter/exit from festival grounds once street closures are in place.

**ITALIAN FEST  
ACTIVITY INDEMNIFICATION  
AGREEMENT**

This agreement was made by and between the ITALIAN FEST Committee (IFC), Collinsville Chamber of Commerce, Inc. (CCofC), and (hereinafter Indemnitor):
